## Minutes of the Parish Council Meeting of Weekley Parish Council held in Weekley Village Hall, on Tuesday 4<sup>th</sup> December 2018

85. **Apologies** had been received from Cllr Cuckson and Cllr Gladstone-Brown and were accepted.
86. **There were no Declaration of Interests** received
87. The amount of the traffic still using Weekley Wood Lane was raised during **the Public Session**, one resident had rung the police on 101 and also e-mailed the police with no response. Cllr Tartaglia explained the cost implications of obtaining a Traffic Regulation Order and that it may not work. Litter is being left by the litter bin, although KBC do empty the bin regularly they leave the litter lying on the ground. It seems that the CCTV dummy camera worked for a while, but not now. One of the CCTV signs has been ripped off. Two residents agreed to look into the cost of purchasing 2 solar panel LED lights or PIR lights.  
A resident asked why there was no a road sign indicating Weekley Wood Lane as some delivery people miss the road, Cllr Chew explained that the properties in Weekley are just known by the number and not street names. The Clerk agreed to investigate this with KBC.
88. **Reports**  
**Rural Forum:** Cllr Hales attended the meeting held at Bowling Green Lane, the main subject was travellers using common land, and there is a new Police Act which gives the Police the ability to move travellers on earlier than before. The unity authority was spoken about but no further update.  
**East Kettering Liaison Forum:** the next meeting is on Thursday 6<sup>th</sup> December.  
**Neighbourhood Watch:** Sharon Lane was unable to attend the meeting but had e-mailed the following report: There are still 18 members of the Neighbourhood Watch. In September a resident had a couple of garden pots stolen from their front garden and in November a resident was made aware of prowlers to the rear of their property. The WhatsApp group continues to be used for missing pets, both of which have been found. There was a notification of WhatsApp hack this did turn out to be a hoax and I am grateful for any messages/notifications. The newsletters will be delivered ASAP.
89. **Parish Council Meeting** held on 21<sup>st</sup> August 2018 were resolved, approved and signed as an accurate record of decisions made.
90. **Action points** arising from Minutes of last meeting
- CCTV along Weekley Wood Lane was covered in item 87.
  - Cllr Hales has spoken to Morelock who have confirmed that an upgrade may cost more than replacing the current one. Cllr Hales agreed to get a photo of the current to Morelock so that they can investigate and quote for an upgrade and a replacement.
